## **ONLINE SEMINAR**

SAFETY AND SECURITY OF RADIOACTIVE MATERIALS FOR INDUSTRIAL RADIOGRAPHY

#### INTRODUCTION

Increasing number of incidents that involved radiation safety and security of radioactive sources used for radiography inspection such as source loss, source stolen, radiography accidents and cases of over exposures amongst operators have alarmed the authority and created anxiety among member of public. AELB as an authority responsible for the enforcement of Act 304 urgently wish to meet all Radiation (RPO)/Radiation Protection Officers Protection Supervisors (RPS)/Personnel Responsible for the License (OBTL)/Radiography Operators to present the current situation related to this matter and furthermore to provide opportunities to all licensees (radiography) to present their cases and constrain faced by the licensee for complying to the requirement of Act 304.
