Another problem faced is the payment from the main contractor, whereby the payment period received was not according to the Purchase Order or Contract Agreement. This situation leads the company to find external funding to pay the employee's salaries. The external fund is used only to pay the basic monthly wage, which does not include their allowances.

However, the company is still trying their very best to prevent from going bankrupt to survive during this pandemic. It is hoped that the relevant authorities will provide financial assistance that can help the company operating.


#### • DEMONSTRATION

## WINNER INSPECTION SDN BHD

Problems and challenges faced by Winner Inspection Sdn Bhd throughout the pandemic period are the difficulties in sending the employees to renew their competency certificates such as the RT and UT certificates, etc.

Besides, the company has to bear the extra cost such as the expensive flight tickets (to Kuala Lumpur, Kota Kinabalu, or Miri), 10 - 14 days of quarantine at a hotel, price of the swab tests (before and after entering the State), meals and laundry services. The situation worsens when the payments from the clients are late.

The company also faces difficulties in providing workforces according to client's requests, especially for

offshore activities. Each employee should be quarantined for 14 days before boarding an offshore platform and again quarantined for 3 -10 more days after coming back from the offshore platform.

Additionally, the employees who are called to work must undergo a PCR swab test. A lot of time is wasted for the employees due to the quarantine process. However, the company will still do its best to provide services to its clients despite the problems and challenges faced during this pandemic.

# ALTEC INDUSTRIAL & ENGINEERING SUPPLY SDN BHD

The unprecedented Covid-19 pandemic disturbed the worldwide supply chain and change ways of doing business. The Altec Industrial & Engineering Supply Sdn Bhd is a distributor and supplier for NDT products and is currently facing various logistics, marketing, and sales and after-sales support and finance challenges.

The challenges in logistics are the in-bound and outbound (airfreight or sea freight), increased cost of transportation, uncertainty on the flight schedule, and space availability and limitation in the movement due to travel restriction (MITI or PDRM approval). The 66

customer's project was also delayed, which also impacted Altec due to decreasing demand. The company is unable to operate with full force due to the reduction of human resources. The international supply chain of raw materials used in manufacturing and packaging has been disrupted, resulting in a lack of finished goods. Additional cost to operate incurred due to swab test, quarantine, sanitization materials etc.

In marketing, sales and after-sales support, the company can deliver the equipment by the courier services but is unable to train them at their site due to travel restrictions. Limitations of virtual training occurred due to some of the customers do not have the facilities. Seminars on the latest technologies are unable to carry out in Malaysia due to no clearance to travel for the principals. Besides, several active projects in East Malaysia cannot be supported due to travel restrictions and the quarantine process. Visits to specific factories are not allowed without the swab test. Hence it restricts the movement on the frontline support.

Also, during this crucial period, the finance or credit companies limit the facilities to their customers. The company faced difficulties with selling or introduced advanced equipment to customers due to financial limitations.











### Malaysia's first certified SKM ISO 9712 Radiographic Testing – Digital (RT-D) Level II personnel

It is a pleasure to announce that Malaysia has managed to produced certified personnel for Radiographic Testing – Digital (RT – D) in accordance with ISO 9712 under the national certification (SKM) for NDT. As such an historic event for NDT in Malaysia, it doesn't get any better when apparently the first two personnel to be certified are both females.

Ms. Noorhazleena Azaman and Dr. Sapizah Rahim from the Malaysian Nuclear Agency are among the first group of participants for the RT – D training course and examination conducted in 2020. After fulfilling the industrial experience requirement, they were the first to apply and then approved by JPK in 2021 to be certified in RT – D Level II.





The RT – D certification under the Malaysian Certification
Scheme became a reality after the great effort made by JPK to introduce advanced NDT certification and remain competitive in NDT certification at the national and international level. This was also made possible by the strong support given by MSNT, DSM and the International Atomic Energy Agency (IAEA).

## REVISED CODE OF PRACTICE

The Atomic Energy Licensing Board (AELB) has published the second revision of Lem/Tek/33, The Code of Practice on Radiation Protection in Industrial Radiography.

The revised document is written based on the new recommendations by the International Atomic Energy Agency (IAEA) and local industries. Industrial radiography service providers, plant owners, and stakeholders are recommended to revise their program, procedure and plan based on the revised document, accordingly.
